

## Isuzu Quick Guide for Core Returns/Destructions

Core charges and returnable shipping skid core charges (specific to remanufactured engine purchases only) for engine models and long blocks when applicable:

<sup>&</sup>lt;sup>1</sup> Partial (100/50/0) core credit reimbursement criteria will be subject to like-for-like engines only or an acceptable alternative as approved through the ISZAPT Service Department specific to products either in production at the remanufacturing facility or planned for future roll out in the remanufacturing program. Core credit reimbursement parameters are defined within the "Engine Core Acceptance Criteria" and "Isuzu Reman Engine Core Return Instructions" documents. It is also important to note warranty-related core returns will be credited 100%; warranty verification will be confirmed by the ISZAPT Service Department.

<sup>&</sup>lt;sup>2</sup>Units sold through the Isuzu Reman program are subject to an additional core charge. This core is for the returnable packaging the unit is shipped on. The core should be returned on the racking originally provided with the remanufactured unit and the credit will be issued during the core return processing administrative process. The remanufacturing facility will confirm receipt of the rack at the time of initial inspection of the core.
